2024 NC Building Code

Several volumes of the proposed 2024 NC Building Code were introduced as B-items at the June 13th Building Code Council Meeting.

Update: Split into B-4A (Mechanical) and B-4B (Fuel Gas) at the 6/13/23 NCBCC Meeting. Prohibited from NCBCC permanent rule adoption by NCGS Session Law 2023-108 on 8/16/2023.

NC Residential Code Chapters 12-23 (Mechanical) as proposed by the Mechanical standing committee

Update: Prohibited from NCBCC permanent rule adoption by NCGS Session Law 2023-108 on 8/16/2023.

NC Residential Code Chapter 24 (Fuel Gas) as proposed by the Mechanical standing committee

Update: Split into B-6A (Energy) and B-6B (Mechanical) and 6C (Fuel Gas) at the 6/13/23 NCBCC Meeting. Prohibited from NCBCC permanent rule adoption by NCGS Session Law 2023-108 on 8/16/2023.

NC Residential Code Chapter 11 (Energy) from 2018 NC Code, and Chapter 12-23 (Mechanical)

Update: Prohibited from NCBCC permanent rule adoption by NCGS Session Law 2023-108 on 8/16/2023.

The Residential standing committee had introduced (in the March 2023 meeting) a submittal that would keep the Chapter 11 (Energy), Chapters 12-23 (Mechanical) and Chapter 24 (Fuel Gas) the same as the 2018 version of the NC Residential Code. At the June meeting, the Residential committee, after much discussion with the Mechanical and Fuel Gas ad hoc committees agreed to have the Chapter 11(Energy), Chapter 12-23 (Mechanical) and Chapter 24 (Fuel Gas) submitted as three separate items, so they can each be decided on individually. The Residential ad hoc committee had submitted their versions of these three items, and the Energy, Mechanical, and Fuel Gas ad hoc committees (via the Mechanical Standing Committee) have submitted their recommended versions, respectively. As noted above, NCGS Session Law 2023-108 prohibits further action on a several of the code volumes and combinations of code volumes that were being considered by the Building Code Council.


