The resources provided through this program play an important role in helping fire departments purchase essential equipment and facilitating capital improvements. VOLUNTEER FIRE DEPARTMENT FUND

During the 1987 Legislative Session, House Bill 166 was ratified creating the "Volunteer Fire Department Fund" (G.S. 118-50) which has been recodified and is now 58-87-1.

This fund was established to assist volunteer fire departments in purchasing equipment and making capital improvements. The fund is administered by the Office of State Fire Marshal. The State Treasurer invests its assets according to law and the earnings remain in the fund.

Grants are eligible to fire departments subject to the following limitations:

- 1. The size of the grant may not exceed \$40,000.00
- 2. The applicant shall match the grant on a dollar-for-dollar basis unless the department receives less than \$50,000.00 per year from municipal and county funding, in which case the applicants are not required to match the grant funding. Applicants receiving more than \$50,000 but less than \$75,000 per year from municipal and county funding shall match \$1 for each \$3 of grant funds.
- 3. The grant may be used only for equipment purchases or capital expenditures necessary to provide fire protection services
- 4. An applicant may receive no more than one grant per fiscal year.

A fire department is eligible for a grant through this fund if:

- It serves a response area of 12,000 or less in population, and
- It is volunteer, may have (8) paid positions, and
- It has been certified by the Department of Insurance

The major emphasis of this program is firefighter safety. Firefighter safety equipment receives the highest priority. Request for vehicles and capital expenditures are also considered. Each application is received and scored using a non-subjective point system. The point system is based on each aspect of an application's per capita income, number and age of vehicles (only if requesting a vehicle), whether the department is all volunteer or paid personnel, financial status and the type of equipment requested.

Every eligible fire department in North Carolina was notified of the online application and a detailed letter of instruction was mailed on January 2, 2025. Online applications were accepted through March 1, 2025.

There were 671 applications received for evaluation, of these, 485 fire departments received matching funds through the Volunteer Fire Department Fund. There were 97 applications withdrawn, disqualified, or incomplete.

Attached to this report you will find a list of approved departments by county along with the amounts they were awarded. The amounts in this report are either 100 %, three quarters or one-half the cost of the equipment to be purchased based on their eligibility to receive a full 100 %, 3:1 (75/25) or 50/50 matching fund.

All fire departments submitting a Volunteer Fire Department Fund application were notified by email of their approved or non-approved status on May 15, 2025.

Approved fire departments are presently purchasing and receiving their approved equipment. Upon delivery of their equipment, they will upload their documentation (invoices and proof of payments) for reimbursement. The deadline for submitting this information to the Department of Insurance is September 30, 2025.

The checks are delivered by mail or electronic transfer funds will be deposited to each approved fire department. The equipment purchased through this grant must remain in the possession of the fire department for a minimum of five years and is subject to inspection or audit which is carried out by our inspection staff.

For the Volunteer Fire Department Grant, G.S. 58-87-1 requires grants to be awarded on May 15. As a result, the grant cycle is usually from April 1 through March 31 for each year. In 2024, May 1 was used as the start of the grant cycle, making the grant year 4/1/2024 to 3/31/2025 in 2025. May 1 was again used as the start of the grant cycle for the 2025 Grant Year, but the grant cycle will end on April 30 to return to the usual grant cycle.

G.S. 58-87-1 requires this report to be filed with the legislature within 60 days of awarding the grant which is before the grant cycle for the awards has ended. Because of this we think it is appropriate to report the beginning fund balance, cash receipts, cash disbursements and ending fund balance for the previous grant cycle (and the ending fund balance would be the beginning balance for the new grant cycle).
