Careers in Code Enforcement – Building and Fire

Protect citizen lives and property in their homes and businesses

State and local governments advertise <u>job openings</u> for code enforcement officials, commonly known as "Building and Fire Inspectors." Your education and experience may prequalify you for employment for such work even if you do not already have construction industry experience. There are hundreds of North Carolina counties and cities that employ code enforcement officials certified by the <u>NC Code Officials Qualification Board</u>. Salaries are competitive with other construction industry jobs depending upon the number and level of certifications attained and years of experience. You may even be hired by a local government on a probationary basis for three (3) years during which time you will get supervised On-the-Job-Training (OJT) and attend mandatory Board courses taught through the NC Community College System. See page 2 for the building occupancy and sizes that each Level is authorized to inspect.

Anyone that has served in the **military** has already demonstrated attention to detail, a sense of commitment to serve others, and successfully complete education and training needed to perform a job critical to an organizational mission. These qualities are exactly what it takes to be a building or fire code official working for a local government! Most service men and women are planning to live somewhere in particular and then find a job. Many remain near their last post because that is where their friends are and have connections to the community.

The online application process begins by creating a username and password through the <u>SYSTEM LOG-IN</u> link on the <u>OSFM web site</u>. Complete the application by providing sufficient documentation to support all education and experience claimed to meet the minimum requirements applicable to the Trade and Level of certification sought and pay the fee of \$20. Your application will be reviewed by NC Department of Insurance staff to the Board and provide further instructions.

All applicants must successfully complete the Board course in Law and Administration and for the Trade and Level which they qualify by their education and experience as provided by Board Rule 11 NCAC 08.0706. The NC Community College System serves as the education sponsor for all Board courses. Applicants must register for the Board course they plan to attend by contacting the specific community college education coordinator or instructor offering the course. A list of scheduled courses is available through the OSFM web site. Course credit is applied upon successful completion when the course roster is submitted.

After all education and experience requirements are met staff will issue an exam eligibility to allow registration for the State exam administered through a testing agency.
