2025 FIRE FATALITIES REACH 158

Preliminary data shows that 158 people lost their lives in fires across North

Carolina in 2025. While these numbers are still being finalized, they serve as a sobering reminder of why fire safety and prevention remain so important. For context, North Carolina recorded 123 fire fatalities in 2024 and 146 in 2023. A full 2025 Fire Fatality Report, including more detailed data and trends, will be released at the end of January.

We'll share more information soon and remain focused on working together to reduce these numbers in the year ahead.



LEADERSHIP UPDATE NEW CHIEF DEPUTY ANNOUNCED

VOLUNTEER FIRE DEPARTMENT FUND GRANT OPENS JANUARY 1

The Volunteer Fire Department Fund Grant, which opened on January 1, 2026, provides financial support to volunteer fire departments across North Carolina for equipment purchases and capital improvements.

Eligible departments must be primarily volunteer-based, meet NC DOI requirements, and report to NFIRS. Funding includes tiered matching requirements based on annual budget, with grants up to \$40,000 per department. Full details and the online application will be available on the Volunteer Fire Department Fund webpage.

OSFM encourages eligible departments to apply early to strengthen safety and service in their communities.

NERIS IS COMING: WHAT DEPARTMENTS NEED TO KNOW...



Starting January 1, 2026, all North Carolina fire departments will use the National Emergency Response Information System (NERIS) for incident reporting.

Continue reporting to NFIRS through December 31, 2025, and submit all 2025 reports by January 15, 2026, when NFIRS shuts down.

NERIS replaces NFIRS with a modern, accurate, and integrated reporting system. Departments can keep using their current RMS software, such as ImageTrend, ESO, First Due, FireWorks, or other approved vendors.

Complete Phase 1 onboarding: log into NERIS, verify your department and GIS details, confirm contact information, and add your RMS vendor client ID. Onboarding emails were sent out on July 9, 2025. If you did not receive one, please contact NERIS.

UPDATES

TRAINING PROGRAMS

Several training programs are being developed with launches over the next two years. The Fire and Life Safety Educator program starts July 1, 2026. Updates to the Fire Officer and Fire Instructor programs begin January 1, 2027. The Firefighter and Driver Operator update follows July 1, 2027. Development is prioritized by need.

INSTRUCTOR QUALIFICATION

The Instructor Qualifications process changes in 2026. Details with dates and locations for required updates or training will be announced soon. Departments and instructors should watch for these announcements to stay compliant and maintain credentials.

FIRE INVESTIGATION UNIT

Since January 1, 2025, the Fire Investigation Unit (FIU) responded to 232 fire scene examinations, averaging 19 per month — a 36% increase from 171 in 2024. These incidents led to \$135 million in property damage, 69 fatalities, and 70 injuries, compared to 37 fatalities and 30 injuries last year. North Carolina recorded 158 fire-related fatalities from 136 incidents, according to the Fire Fatality Tracker. This year, FIU became 100% certified. All nine investigators hold NC-CFI certification; three also have IAAI-CFI credentials, showing the unit's commitment to professionalism and public safety.



EVERYONE GOES HOME®

The NC Everyone Goes Home Team had a busy and impactful 2025, delivering 52 Leadership, Injury, and Line-of-Duty Death (LODD) Prevention classes to 617 attendees across NC. In 2026, the team will launch five brand-new classes focused on firefighter safety and leadership. Did you know?

The Swiftwater Training Channel and Village is now open and provides a 783-foot channel for boat operations, structure and vehicle searches, high-water vehicle rescues, swim and surface water training, and helicopter rescues from elevated structures.

The NC ETC is scheduling ARFF and Swiftwater Rescue classes for 2026. Firefighters can receive advanced, hands-on training. Departments can find details through the NC ETC website via OSFM. Boat Operator Pilot Classes are March 2–6, April 20–24, and May 11–15, 2026. These courses teach essential skills for flood, swift water, and water emergency response.

XTRA UPDATES

RATINGS AND INSPECTIONS

The updated Fire Department Administrative Rules are still under review with the Office of Administrative Hearings (OAH), with a tentative final approval date of March 1, 2026. The Class 9 Outreach Program had an outstanding year in 2025. Through targeted outreach, our team was able to rate or schedule 17 fire departments for the very first time. Thanks to this progress, we anticipate reducing the number of Class 9 departments statewide to just 114 by the second quarter of 2026. STATE FIRE MARSHAL ADVOCATES FOR FIRE SERVICE ROLE IN FEMA REFORM

The FEMA Review Council was created in January 2025 by President Trump through Executive Order 14180. The council's mission is to review the Federal Emergency Management Agency (FEMA) and recommend major reforms to improve how the nation prepares for, responds to, and recovers from disasters. North Carolina State Fire Marshal, who also serves as Vice President of the National Association of State Fire Marshals (NASFM), has been a strong advocate for including the fire service in these discussions. Currently, the FEMA Review Council does not include any direct fire service representation, a gap the Fire Marshal believes must be addressed. To raise these concerns, the State Fire Marshal has sent formal letters to Homeland Security Secretary Noem and to each member of the FEMA Review Council, urging them to —

MEET THE STATE PROPERTY FIRE INSURANCE FUND- PROTECTING NORTH CAROLINA'S PUBLIC ASSETS



When disaster strikes, it's essential that our state agencies and universities can recover quickly and keep serving the people of North Carolina. That's where the State Property Fire Insurance Fund comes in. This fund provides fire and lightning coverage for state-owned buildings, structures, and business personal property, ensuring critical public operations can bounce back after a loss.

What does the fund protect?

All state agencies and universities, in addition to state-owned buildings and structures. This includes items such as business personal property (equipment, furnishings, and other assets inside those facilities).

It's a vital safety net that helps keep North Carolina running smoothly, even in the face of unexpected damage.

By providing financial protection and risk management support, the State Property Fire Insurance Fund

helps North Carolina recover faster from losses, maintain continuity of services and protect taxpayer investments. Agencies can also expand their protection to include damage from theft, water damage, and other perils beyond fire and lightning. These options help safeguard essential property and ensure that operations continue without major interruptions.

— include fire service leadership in FEMA and U.S. Fire Administration reform efforts.

During the council's visit to Asheville to assess the aftermath of Hurricane Helene, the State Fire Marshal was invited to participate in a closed meeting. At that meeting, he provided the council with a written document outlining recommended improvements to disaster response and coordination. Former FEMA Director and North Carolina native Brock Long has emphasized that FEMA and emergency management agencies are not response agencies. Instead, he has stressed that the U.S. Fire Administration and the fire service must be elevated within the national disaster response framework, specifically within Emergency Support Functions (ESF) 4, 9, and 10 at both the national and state levels. Over the past year, the State Fire Marshal has traveled across the country speaking to corporate and government audiences about lessons learned from Hurricane Helene and the need for meaningful disaster response reform. Additional recommendations of NASFM and the International Association of Fire Chiefs (IAFC) agreed on as members of the National Advisory Committee (NAC) can be found in a report released by the Congressional Fire Services Institute (CFSI). That report, along with the State Fire Marshal's letters to the FEMA Review Council, provides further insight into proposed reforms to strengthen disaster response nationwide.
