#### North Carolina Emergency Training Center Update

Construction is progressing on the NC Emergency Training Center at the Stanly County Airport in New London. Part of the center is already completed, and Phase One is expected to wrap up by September. So far, \$87 million has been invested in the project.

This new center is being developed in collaboration with the Office of State Fire Marshal (OSFM), Stanly County, and the NC Air National Guard Fire Department. It will provide firefighters and rescue teams with a facility to train for real-life emergencies.

The training areas will include:

- Aircraft firefighting, featuring a full-size crash simulator
- Swift water rescue, conducted in a safe and controlled environment
- Urban search and rescue
- Hazardous materials response
- Fire investigation certification

One of the center's standout features is its water rescue area, which is the only facility in the U.S. that allows motorized boats to be used for training. This will equip first responders to handle flooding and storm-related rescues, especially in light of the recent hurricanes and heavy rainfall experienced across the state. The center is already operational for FAA-required aircraft rescue training, drawing participation from emergency teams throughout North Carolina.

To facilitate the opening of the water rescue section, OSFM requested a waiver for over \$16,000 in water fees to provide five million gallons of water. The Albemarle City Council unanimously approved this request. This facility will serve as a crucial resource for training and preparing North Carolina's first responders for various types of emergencies.

#### Disaster Recovery Grant Program Update: Funding in Progress

The Office of State Fire Marshal (OSFM) began sending notifications for the Disaster Recovery Grant Program on June 30. In Round 1, 206 fire departments submitted funding requests totaling more than \$44 million, although only \$10 million was available.

Some applications included ineligible items or lacked detailed budgets. OSFM has contacted those departments to revise their submissions. In the meantime, placeholder award amounts have been issued to maintain momentum. As corrected budgets are received, any unallocated funds are being redistributed to the next departments in line. This ongoing process is why funding decisions are still being finalized.

Round 2 of the program, backed by new state funding (S.L. 2025-26), adds \$18 million and expands eligibility. This includes:

- Two additional counties (15 new fire departments eligible)
- Removal of five counties (affecting 31 departments)
- 36 rescue squads added to the eligibility list

The second round is designed to help departments repair or replace equipment and facilities damaged by Hurricane Helene or enhance their wildfire response capabilities. A total of 24 counties in Western North Carolina, including Buncombe, Henderson, and Watauga, are eligible.

Applications are being reviewed using a fair and transparent scoring system. Once both rounds are complete, OSFM will publish a full list of awards on its website.

Although the grant platform wasn't originally built for a program of this scale, OSFM staff are working diligently to manage the process. Departments that have not received prior OSFM grants may need to be added to the state payment system before receiving funds.

Funding will continue to be awarded and distributed until all available resources are allocated.
