Harley Cook made the following statement:

Pursuant to North Carolina General Statutes, Section 58-78-5(a)(15), the Fire and Rescue Commission is authorized to create boards to assist in its functions and duties. One of the boards created by the Fire and Rescue Commission is the Certification Board. The membership on the Certification Board consists of one permanent member and 13-time limited members who may be removed for cause or resignation. The Fire and Rescue Commission bylaws establish time-limited membership and appointments to the Certification Board. According to the North Carolina Fire Rescue Commission bylaws, the Certification Board shall consist of one appointee by the Fire Rescue Commission Chair, one appointee by the Fire Rescue Commission Vice Chair and twelve individuals nominated and elected at a regularly scheduled and announced Fire and Rescue Commission meeting. Given a January 2026 public records request to OSFM and a recent North Carolina ethics confidential complaint, the election and appointments to the Certification Board are delayed until the next April 14, 2026, Fire Rescue Commission meeting. There will be no changes to the current representation of the Certification Board until the April 14, 2026, meeting.

**Certification Board – Joel Faircloth**

**Technical Rescuer** – Task book for collapse is complete and the one for Machinery is being developed. This will soon be completed, and the qualified instructors will be notified. Once these are complete, work will begin on Wilderness. The boat operator developed is proceeding and will be piloted soon. Flood water will be added to the boat operator course. Both courses will be run at the Emergency Training Center.

**Haz-Mat** – All updates have been completed, instructors have been qualified, and these programs went live on January 01, 2026.

**FLSE** – Updates continue and the new program will go live July 01, 2026.

**Driver Operator** – Updates continue and the new program will go live July 01, 2027.

**Firefighter** – Updates continue and the new program will go live July 01, 2027.

**Fire Instructor/Officer** – Will begin soon and the new program will go live January 01, 2027.

Commission Meeting Report –

**Staff updates** – Joe Ramsey has joined OSFM as a Certification Specialist and will be serving Region 3 and Region 2-west.

New Business –

**Asheville Fire Department** – Requested the additional of five TR programs: Surface water, Swift water, Wilderness, Trench, and Confined Space. Approved

The CB requested Staff look at the delivery agency moratorium and report back to the CB in March 2026.

**RIT/BES** – OSFM Staff recommended that RIT qualification become a field-delivered qualification, to include an exam and skills; to match other field-delivered qualifications. Approved.

**Recognition of Jim Hanline** – The CB, and OSFM Staff, recognized Jim Hanline for his 38-years of service to the Certification Board.

Closed Session –

The closed session dealt with an incident that occurred at WPCC on October 12, 2025. This incident became known through a reported injury (this injury was a life-threatening incident which occurred in a water rescue course).

Freddy Johson asked the Certification Board to look at the firefighter certification block format.

Robert Poe asked about the removal of knives from the water course. Kevin Gordon advised staff working on the use of knives and what options are available.

## **VSWCF – Cloyce Anders**

There have been no premiums for the last four years. Departments should still budget for the premiums in case the premiums are required. Cloyce reviewed the financials. The cost of claims is going up. Sedgewick is doing a good job managing the fund.

## **Certified Fire Investigator Board – Freddy Johnson**

Meetings are being moved back by one month. Items for review have been put in your packets. Freddy asked that those items to be reviewed so that a vote can be made at the April FRC meeting.

In 2025 the CFI reviewed 46 applications. 43 approved and 4 denied.

## **New Business**

### **NEIRS Update – Monna Gillespie**

FEMA will decommission the NFIRS system on January 31, 2026. Data from 2012 to present will be available in the Image Trend system. NEIRS went live for everyone January 1, 2026. Image Trend allows access to NFIRS data and run reports.

### **Kyle Heuser**

No change. We are waiting on the Omnibus Bill to pass giving the Fire and Rescue Commission statutory authority.

### **OSFM – Brian Taylor**

Mike Williams has retired. Brian Wade has been promoted to his position. Kevin Gordon has been selected as the interim Division Chief.

Davey Summey is retiring in March.

OSFM staff will be meeting with the Gen Gov group on February 3rd to discuss our budget requests. A mini budget provided OSFM with an HR and Budget position.

**OSFM Brian Wade** – Joe Ramsey has been hired as a Certification Specialist.

**OSFM Kevin Gordon** – The Instructor Qualification process is changing slightly. Firefighter Qualifications will be offered five times a year. 1 in each certification region. Written Qualifications will be offered 20 times a year. Field Qualification delivery will remain the same. CFI exams will be given after the CFI meetings. They will be delivered in three regions, East, Piedmont and West.

### **NCSFA – Barry Overman**

Ed Brinson retired December 31, 2025.

Rosters are due Thursday January 15<sup>th</sup>. NCSFA staff will call departments who have not submitted their rosters. Cancer benefits have paid out to 24 eligible applicants. VFIS is doing an excellent job handling the process. Requests for relief fund use have increased. Scholarships applications opened on January 1<sup>st</sup>. May 20<sup>th</sup> is Firefighter Legislative Day.

### **NC Department of Labor – Mike Say**

- There has been no new activity on the proposed Emergency Responder standard from Federal OSHA. The latest window to provide comments and feedback on the proposed standard ended in early January 2025, and there have been no new actions taken to report.
- Federal OSHA continues to work on their Heat Stress standard. The latest window to provide comments and feedback on the proposed standard ended in July 2025. OSHA is currently reviewing the comments and working on revising their proposed standard. No word on when the next draft of the proposed standard will be published.

- In North Carolina, Commissioner of Labor Luke Farley has established the Commissioner’s Heat Stress Advisory Council, a new advisory body designed to strengthen worker protections and address heat-related illness and injury in the workplace. The Heat Stress Advisory Council will serve as a collaborative forum bringing together representatives from diverse industries and disciplines, including one from the Professional Fire Fighters & Paramedics of North Carolina (Scott Mullins). Council members will share expertise and provide recommendations to improve heat safety standards in North Carolina workplaces. The Council’s work will focus on reviewing existing laws, evaluating current regulations, and advising on potential policy improvements—all with the goal of protecting workers from preventable injuries and unsafe conditions.
