

English as a Second Language (ESL) Accommodation

English as a second language (ESL) examinees may receive up to 1.5X the standard time allotted for the test. The Home Inspector Exam has a 4-hour time limit. With **approved** documentation, an examinee is allowed up to 6 hours to complete the exam.

To qualify as an ESL examinee, documentation is required.

Submit ONE of the following prior to scheduling an exam:

1. Score of 85 or below on the *Test of English as a Foreign Language, Internet-Based Test* (TOEFL-iBT), taken within the two (2) years prior to application.

<u>Documentation Required</u>: Your TOEFL-iBT scores must be sent directly, or you may attach them in an envelope that has been SEALED BY ETS. (See the mailing address below.)

2. Prior ESL accommodation.

<u>Documentation Required</u>: Attach documentation showing prior ESL accommodation.

3. Letter from testing/educational institution, medical provider, or qualified professional.

<u>Documentation Required</u>: A letter from a testing/educational institution regarding extended time for ESL students clearly stating the student's need for the accommodation, and the rationale behind it.

IMPORTANT: Allow 30 days for processing. Accommodations <u>MUST</u> be approved by OSFM Staff.
