Recall Rundown: Essential Insights for CPSTs on Car Seats and Vehicle Safety Recalls – (1 CEU)

Leave preconceived notions about vehicle safety recalls at the door. This 60-minute session will provide technical information to participants in various aspects of vehicle safety recalls that directly affect child safety seat installation. Participants will gain in-depth knowledge from technical service bulletins of specific safety recalls involving lower anchors, top tethers, seat belts, head restraints, and other vehicle components that can interfere or prevent proper child safety seat installation and the ramifications of these recalls on child occupant safety. Participants will also learn about other vehicle occupant protection safety recalls, with technical insights about the reason for the recall and the significant risks to children in child safety seats, emphasizing the importance of addressing these issues to prevent serious injuries.

Understanding Alzheimer's and Dementia

This program details potential 911 calls you may encounter, how to respond as well as tips and strategies for working with individuals living with the disease.

The National Digital Car Seat Check Form is a free HIPAA-compliant resource available to all certified Child Passenger Safety Technicians. Available on paper or an electronic platform, this program walks a technician through a structured car seat check, streamlining data collection so that important information is captured along the way. CPSTs and program managers can easily download their seat check data in a format that reduces reporting burdens, allows for monitoring trends, and tracking car seat distributions.

Pediatric Vehicular Heatstroke: Resources, Advocacy & Action

Occupant Protection at Any Age and at Every Stage

Kristel Robison, Senior Research Associate, UNC Highway Safety Research Center Shannen Johnson, UNC Highway Safety Research Center, Junior Research Associate

As child passenger safety professionals, we understand how critical proper restraint and safety seats are when transporting young passengers. We also understand how installation of car seats can potentially impact the front seat passengers, particularly in smaller vehicles. Knowing this, how can you better balance the needs of all passengers, each of whom deserves to be protected during transport? This is where programs like CarFit help assist in that mission, and can work in conjunction with child passenger safety, so everyone is safe in the vehicle. CarFit is a national program that promotes safe driving and mobility by focusing on safety, comfort, and fit in a driver's personal vehicle. Trained CarFit Technicians educate drivers on key areas of occupant protection such as airbags, seat belts, and head restraints as well as vehicle adjustments (mirror, seat position, steering wheel tilt, etc.). Although the program is geared towards older drivers, these safety points are important for everyone, including children transitioning out of boosters, new drivers, and those trying to maintain the best safety practices while on the road. By merging key concepts from CarFit with CPS expertise, we can better recognize the impact that can be made across generations to ensure all riders are safe, regardless of where they are sitting. Safer drivers at any stage make for safer occupants at every age.

Using AI to Enhance Educational Messages and Outreach

Brene Ball, Pinecroft Sedgefield Fire District, Fire and Life Safety Educator/Digital Content Specialist

Artificial intelligence (AI) tools have been all over the internet for the past few years. By now you have seen many pop up and may have already used some to see what they can do. Did you know they don't have to be a scary tool? As an educator, you can use these AI tools to build educational messaging to fit specific audiences, help analyze data and create digital content and even use them to save you time as you work on your outreach programs. This 90-minute session will introduce participants to examples of how these tools work, how they can be used to increase productivity and take data collection and analysis to the next level. Participants will walk away with a list of new tools to integrate into your own programs.

The program enhances the safety and comfort of older drivers through a 12-point checklist guided by trained volunteers. CPS professionals can integrate CarFit into their community programs to improve older driver safety. In this interactive training, participants will learn how to conduct CarFit sessions effectively. How to Obtain the Extra 5.5 Community Risk ISO Points

How to obtain the Extra 5.5 ISO Community Risk Points is a program geared for community risk personnel who are working to reach the public and earn the rightly due points their agency deserves. This presentation allows us to take a deep dive into ISO Community risk points – what are they and where can we find them. Are you leaving points behind, by not knowing what is credible or not. Our presentation will allow for group discussion for the collaboration of ideas amongst all disciplines.

Keeping Families Connected

Lauren Crafton, ROTH ID TAG, Owner

Lauren Crafton will share the story that led her to become a CPST and create the ROTH ID TAG™, a universal emergency identification system for child passengers. Her presentation will explore the story behind the company's development and the gaps in emergency contact information for child passengers. Lauren will discuss how the ROTH ID TAG addresses real-world challenges that first responders encounter, offering an easy-to-use solution. Focusing on the CPST perspective, Lauren will explain how they have collaborated with industry experts to develop a product that integrates seamlessly into safety protocols with a simple design. Attendees will learn how the product is a practical resource, helping CPSTs ensure that children's emergency information is always accessible in the event it is needed. She hopes the ROTH ID TAG will help reduce the trauma of an unidentified and scared child following a vehicle accident for both the child and the first responders. By the end of the presentation, CPSTs will leave with actionable insights on how the ROTH ID TAG complements their work, making it an essential addition to their child safety programs tool kit.
